1. General Information

This policy applies to the website www, operating at the URL: onyxtms.com.

The operator of the website and the Data Controller is: ONYX Alfa Sp. z o.o., Grudziądzka 8A, 82-500 Kwidzyn, Poland.

The operator's email contact address: admin@onyxtms.com.

The operator is the Data Controller of your personal data in relation to the data provided voluntarily on the Website.

The website uses personal data for the following purposes:

- handling inquiries through the form,
- presentation of the offer or information.

The website acquires information about users and their behavior in the following ways:

- through data voluntarily entered into forms, which are entered into the Operator's systems,
- by saving cookie files (so-called "cookies") in end-user devices.

2. Selected Data Protection Methods Used by the Operator

Places of login and input of personal data are protected at the transmission layer (SSL certificate). As a result, personal data and login data, entered on the website, are encrypted on the user's computer and can only be read on the target server.

Personal data stored in the database is encrypted in such a way that only the Operator possessing the key can read it. Thus, the data is protected in case the database is stolen from the server.

User passwords are stored in hashed form. The hashing function works in one direction - it is not possible to reverse its operation, which is the current modern standard in terms of storing user passwords.

Two-factor authentication is used on the website, which constitutes an additional form of protection for logging into the Service.

3. Hosting

The service is hosted (technically maintained) on the operator's server: cloudways.com.

Your Rights and Additional Information on the Use of Data

In certain situations, the Administrator has the right to transfer your personal data to other recipients, if it will be necessary to perform the contract concluded with you or to fulfill the obligations incumbent on the Administrator. This applies to such groups of recipients:

hosting company by way of entrustment.

Your personal data processed by the Administrator no longer than is necessary to perform the related actions specified by separate regulations (e.g., on accounting). With regard to marketing data, the data will not be processed for longer than 3 years.

You have the right to request from the Administrator:

- access to personal data concerning you,

- processing restriction,

You have the right to lodge a complaint with the President of the Personal Data Protection Office, ul. Stawki 2, 00-193 Warsaw.

The provision of personal data is voluntary, but necessary for the Service's operation.

You may be subject to automated decision-making, including profiling, for the purpose of providing services within the framework of the concluded contract and for the Administrator to conduct direct marketing.

Personal data are not transferred to third countries within the meaning of the data protection regulations. This means that we do not send them outside the European Union.

5. Information in Forms

The service collects information voluntarily provided by the user, including personal data if they are provided.

The service may save information about connection parameters (timestamp, IP address).

The service, in some cases, may save information facilitating the linking of data in the form with the email address of the user filling out the form. In such cases, the user's email address appears inside the url of the page containing the form.

Data provided in the form is processed for the purpose resulting from the function of a particular form, e.g., to carry out the process of service request handling or commercial contact, registration of services, etc. Each time the context and description of the form in a clear way inform what it serves for.

6. Administrator Logs

Information about users' behavior on the service may be logged.

These data are used for the administration of the service.

7. Essential Marketing Techniques

The operator uses statistical analysis of website traffic through Google Analytics (Google Inc. based in the USA). The operator does not transfer personal data to the operator of this service, only anonymized information. The service is based on the use of cookies

on the end-user's device. Regarding information about the user's preferences collected by the Google advertising network, the user can view and edit information resulting from cookies using the tool: https://www.google.com/ads/preferences/

8. Information about Cookies

The service uses cookies.

Cookies (so-called "cookies") are IT data, in particular text files, which are stored in the Website User's end device and are intended for use with the Website's web pages. Cookies usually contain the name of the website they come from, the time they are stored on the end device, and a unique number. The entity placing cookies on the Website User's end device and accessing them is the Website operator.

Cookies are used for the following purposes:

- maintaining the website user's session (after logging in), thanks to which the user does not have to re-enter the login and password on every subpage of the Website,
- realization of the objectives defined above in the part "Essential Marketing Techniques".

The Website uses two main types of cookies: "session" (session cookies) and "permanent" (persistent cookies). "Session" cookies are temporary files that are stored on the User's end device until they log

out, leave the website, or disable the software (web browser). "Permanent" cookies are stored on the User's end device for the time specified in the cookies' parameters or until they are deleted by the User. Web browsing software (web browser) usually by default allows the storage of cookies in the User's end device. Website Users can change the settings in this respect. The web browser allows for deleting cookies. It is also possible to automatically block cookies Detailed information on this subject is included in the help or documentation of the web browser.

Restrictions on the use of cookies can affect some of the functionalities available on the Website's web pages. Cookies placed in the Website User's end device may also be used by entities cooperating with the Website operator, in particular, this applies to companies: Google (Google Inc. based in the USA), Facebook (Facebook Inc. based in the USA), Twitter (Twitter Inc. based in the USA).

If the user does not want to receive cookies, they may change the browser settings. We reserve that disabling the handling of cookies necessary for authentication, security, maintaining user preferences may hinder, and in extreme cases, may prevent the use of www pages.
